IV. Updates

1. Judicial Branch: Hon. Susan Sparaco, Chief Judge of the District Court

- New Chief Judge: Hon. Susan Sparaco.
- New Deputy Chief Judge: Hon. Jed French.
- Continuing Education Subcommittee (CES) met in September to begin discussions about the judicial branch's 2020 child protective conference. The dates for the conference will be April 2nd and 3rd.
- Current PC filings: as of September 30, 2019, there has been a 23% statewide increase as compared to the same time last year.
- Judicial Branch's response to the increase in filings:
 - Tracking filings to allow for appropriate scheduling of judicial officers.
 - Increase in CASA guardians ad litem statewide.

 New guardian ad litem course will be offered at the University of Maine School of Law in 2020. This course will satisfy the core training requirement to become a rostered guardian ad litem.

2. Office of Child and Family Services (OCFS): Dr. Todd Landry, Director

- November is National Adoption Month.
- Currently, there are 2,190 children in DHHS custody.
- Data dashboard is currently available on the OCFS website providing information on child welfare, early childhood education, and behavioral health. This is updated every month.
- OCFS has taken the 170 different recommendations from various reports and created a priority list for implementation (handout provided).
- Memo distributed about a pilot project implementing e-discovery.
- Maine has received a federal kinship navigator grant.
- 3. Office of the Maine Attorney General, Child Protective Division: Nora Sosnoff, Assistant Attorney General, Division Chief
 - There has been an increase in threats and personalized intimidation toward AAGs and DHHS caseworkers.
 - Many stakeholder groups are being convened to discuss child welfare issues and the AAGs are glad to be at the table.
 - Discussion about incarcerated parents of children in the child welfare system. Approximately 7% of children in the child welfare system have an incarcerated parent. Contact between the parent and child is not being discouraged by AAGs and some relationships have been formed between the AAGs and prisons.

4. Maine Commission on Indigent Legal Services (MCILS): John Pelletier, Executive Director

- Extended representation for juveniles in Long Creek Youth Development Center (LYDC) has been authorized. Historically, once the juvenile was committed to LYDC, the lawyers representation of that juvenile ended. New practice will be to have continued representation of the juvenile while committed.
- Juveniles who live a significant distance from LCYDC will have local counsel assigned to them to work with appointed counsel in the juvenile's hometown.
- Both extended representation and local counsel will be paid for with existing resources within MCILS.

V. Strategic Plan Updates

- 1. Proposed Task Force Initiatives:
 - **Reunification Plans:** Bobbi Johnson and Mike Kearney have been working on streamlining and simplifying the reunification plan provided to parents and the court.
 - Current draft is similar to previously used reunification plans.

- One concern is that the plan lacks the ability to see who will do what and when.
- Consideration was given to having two plans—one for the court to review with the parent and one for DHHS caseworkers to maintain with more detail.
- A suggestion was made to have an attachment to the reunification plan that outlined action items that need to be accomplished in the next two months.
- **Task Force Information Sharing:** The Maine Child Welfare Advisory Panel (MCWAP) website will be converted to house all three citizen review panels required under the Child Abuse Prevention and Treatment Act (CAPTA) required panels. The first meeting to discuss this will be on November 14th. Content of the website will be developed after the initial meeting.
- **Resource Navigator Pilot Project:** First workgroup meeting was held at the end of October.
 - The first item that needs to addressed is funding. The workgroup is researching options.
 - The Task Force would like to have a trained resource navigator present at the courthouse to provide services to anyone presenting the need for resources while in court.
 - Workgroup Membership: Deputy Chief Judge French, Debra Dunlap, Jamie Brooks, Shawna Lund, Gayle Erdheim, Page Nichols, Bobbi Johnson, Liam Shaw, Betsy Boardman, and Caroline Jova.
- **MaineCare Billing:** Presentation by Dean (waiting on Dean's full name and title) from DHHS concerning payment of mental health professionals, specifically for collateral meetings and court events, involved with child welfare cases.
